What is ISO 50001 certification?

ISO 50001 certification. Includes implementing an energy management system certified to the ISO 50001 standard. Financial assistance can be up to 60% of eligible costs for for-profit organizations and up to 75% of eligible costs for not-for-profit organizations to a maximum of \$40,000 per building.
